Chairwoman Carlotta Harrell to Deliver State of Henry County on April 10 *Over 300 Expected at Annual Address at Grace Baptist Church in Stockbridge*

HENRY COUNTY, GA - The [Council for Quality Growth](#), in partnership with [Henry County](#) and the [Henry Chamber of Commerce](#), will host the 2024 State of Henry County Address on April 10, 2024 at 8:00 AM at Grace Baptist Church in Stockbridge. This year's breakfast is presented by [Geosam Capital Group](#) and [Truist](#) and will feature an annual address from the Chairwoman of Henry County's Board of Commissioners, Carlotta Harrell. 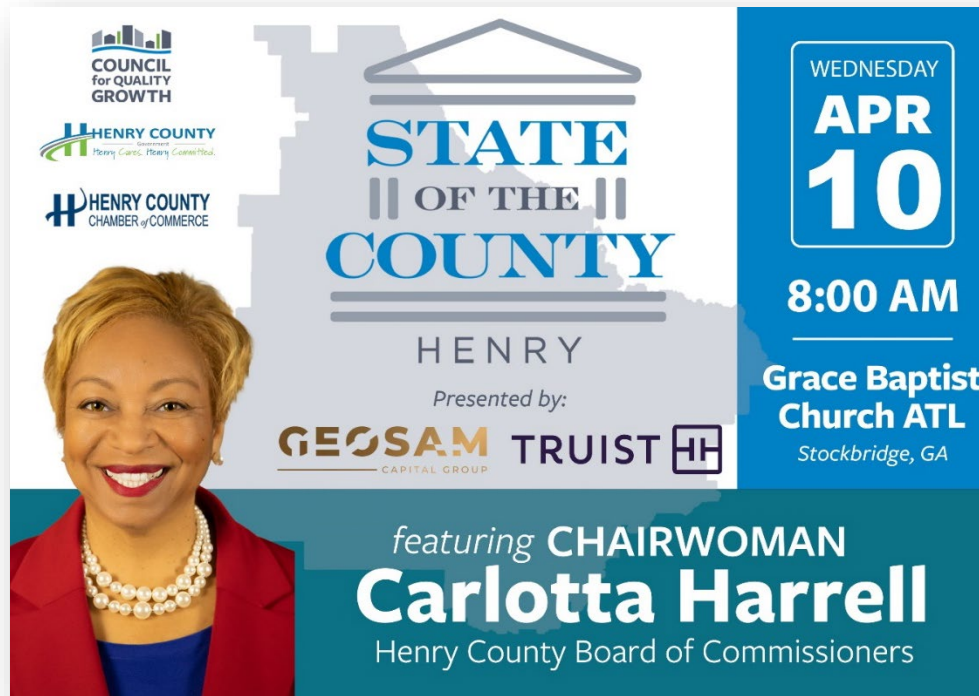
